# 20.007 To report on Progress with Highways:

(a) (19.039) A59 Traffic Calming Measures –

The Clerk read out a letter sent to Howard Ferguson (PA to Nigel Adams MP) regarding speed reduction and traffic calming measures on the A59 crossroads in Moor Monkton and the general frustration of not getting anywhere for the Parish Council. A Parishioner is looking to put together a technical solution as a revised layout plan for the junction after taking advice from the Advanced Drivers' Association, taking into account stopping distances and calculations covering various scenarios. This will then be put to the Parish Council for consideration to support its case in this matter. Once finalised Cllr Paraskos to arrange a meeting with NYCC at Boroughbridge.

# 20.008 (19.088) Lancaster Bomber Memorial Stone

There has been no further action on this as we are awaiting an update from Edlington Town Council.

# 20.009 (19.093) Hedge/Verge Cutting in the Village

The Clerk reported that she had contacted Mr Burniston requesting a price quote for carrying out 1 cut of the verges. Mr Burniston responded with a cost of £70 per cut. Whilst there had been some opposition within the villages, to the cutting of verges, it was decided to stick to the National Guidelines of cuts in Spring / July / Autumn. This was then proposed by Cllr Johnson and seconded by Cllr Gibbs. Trevor Woodward has agreed to speak with Mr Burniston to discuss our requirements.

# 20.010 (19.093) VE Day Celebrations - 8th - 10th May 2020

A meeting has been arranged for 29<sup>th</sup> January, where a sub-committee made up of 2 members from MM Parish Council, 2 members from MM Village Association and 2 members from the RKC will look into how this event can be celebrated.

# 20.011 To receive District and County Councillor's comments.

Cllr Myatt, having recently attended a Flood Emergency Meeting, asked how Moor Monkton faired with this. It was stated that originally, due to post code allocation, Moor Monkton was shown on a flood plain. However this was disputed and not thought to be the case. It was noted that there had been a problem on Boxing Day some 4 years ago, when the Pumping Station had broken down, but no further problems had been experienced.

Cllr Myatt also informed the meeting that the Draft Local Plan was on-going and there was a meeting being held the following week, which should provide more information.

Cllr Paraskos offered to pay from next year's budget, for a street light to be put at the crossroads on the A59 Junction. Cllr Tomlinson asked if Cllr Paraskos could also pay for a 40 miles per hour speed sign to be re-instated on the A59 Western approach to Moor Monkton. Cllr Paraskos agreed to look into it and speak with someone different in NYCC.

Cllr Paraskos also stated that there is a new and improved version of the blue paper and card HBC Recycling bags, and he would provide each house hold within Moor Monkton with one. Action Point: Clerk to let Cllr Paraskos know the numbers required and Cllr Gibbs to arrange to collect from Harrogate.
