21.077 Finance – Moor Monkton Parish Council (MMPC)

- (a) **To receive a financial statement / bank reconciliation in line with HSBC bank statements.** – bank statements were studied by the councillors and approved
- (b) **To note accounts for payment** - approved
- (c) **To note receipt of 2nd instalment of precept** - noted
- (d) **To note the following payments previously authorised:**
 - **Clerks salary (1/8/21 – 31/9/21) and HMRC** - approved
- (e) **Agree precept/budget for 2022/23:**
 - the suggested budget for 22/23 was discussed and approved at a total of £4,470.
 - It was noted that the bank balances on 11th November totalled £12,796.95 - £3,056.35 is still outstanding from the current finance leaving £9,740.60 which are reserved earmarked for village development of playground/tennis court
 - It was agreed to keep the precept at the same as last year at £4,500.
- (f) **To review progress on audit plan/YLCA audit**
 - Cllr R Tomlinson reported he had reviewed the Parish Councils Financial Regulations against the July 2019 (NALC) Model Financial Regulations as suggested by the auditor and proposed a couple of changes. These were agreed and a new version will be put on the website
 - Clerk and Cllr Tomlinson had carried out a Data Audit, all is in order. For completeness the clerk will review the Privacy Notice to be approved at the next meeting and then to be sent with the minutes to all who are on the e-mail distribution list.
 - In line with the Audit Plan, Cllr R Tomlinson has completed an Internal Control exercise – all was correct
 - Clerk reported that we are on track with the Audit Plan for the year and suggested the same version be used for 22/23. This was agreed.

21.078 To receive District and County Councillor's comments (if present).

21.079 To report on other HBC/NYCC issues if not covered in their reports

- **(a) Update on NYCC Unitary Authority proposals**
 - The changes will still go ahead from May 2023, HBC councillors to stay on for one more year
 - There will be a reduction in overall staff number in the new Unitary Authority with the additional benefits of streamlining i.e. highways and planning to be part of the same authority
 - There will be local representatives, however NY will be the biggest Authority covering app 6000,000 people (country average is 400,000) York will stand alone covering 200,000
 - Wards will also change along with boundary changes for Parliamentary constituencies

- The unknown is causing difficulties with staff retention and recruitment across all areas
- **(b) New settlement consultation Hammerton/Cattal area (Development Plan Document – DPD)**
 - Unlikely that any building work will commence until 2024, although liaison groups have been working hard
 - Traffic remains a big issue and is only getting worse with less people using public transport.
 - Network Rail may not have the money to make the changes to the track around Cattle
 - Mitigation for the extra water is also high on the agenda
 - It is likely to move to the new Unitary to be progressed

- 21.080 To report on Progress with highways on specific issues:**
- **(a) (19.039) Update on the new lighting at the crossroads and installation of the 40 mph road signs for the A59.** Cllr Myatt will remind Cllr Paraskos of these two issues and seek his feedback. The angle of the new light needs adjustment so as to cast light onto the A50 junction
 - **(b) (20.131) Report on progress with Speeding/horse signs on Church Lane** – Cllr Myatt will pass on our thanks to Cllr Paraskos for the speedy response to the horse signs and ask for an update on the actual speed limit in the village
 - **(c) update on the effect of extra traffic on A59 with the proposed new settlement above** – covered above
- 21.081 (20.083) Church of England discussions** – Update still requires, **ACTION** – Cllr R Tomlinson and the Clerk to follow up
- 21.082 (20.089) A definitive Map – a simplified version for walkers** – Final maps have been approved and on order - **RESOLVED**
- 21.083 (20.112) Flooding on the cattle grid on the track off the start of East Lane** – Cllr Myatt to ask Cllr Paraskos to get a new contact from Highways as no response has been received from them to date
- 21.084 Concerns of noise from Grasstrack events** – Dates for next year will be placed on notice boards and the website, parishioners are asked to contact if this becomes an issue again - **RESOLVED**
- 21.085 To discuss participation in the Queens Platinum Jubilee including Beacons and Green Canopy – plant a tree** – Following discussions it was agreed there was no suitable place for a Beacon and as the Parish Council does not own any land there is no place to plant trees.
ACTION Clerk will look at options for buying trees for Parishioners to plant on their own land
- 21.086 To receive a Neighbourhood Watch Report** – Still no contact from Neighbourhood watch or Safer Neighbourhood Committee
