Minutes of Parish Council Meeting held on Wednesday 20th March 2019 in the School Room, Moor Monkton at 7.30pm

19.015 To receive declarations of disclosable pecuniary interest (not previously

declared) on any matter of business. None Declared

19.016 To receive apologies and approve reasons for absence.

Apologies were received from Cllr Victoria Sharp whose new puppy was seriously ill with organ failure and this reason was approved.

19.017 To approve the Minutes of the Parish Council Meeting held on Wednesday 16th

January 2019. These had been previously distributed by the Parish Clerk and

were duly signed and approved by Cllr Johnson

19.018 Receiving the Resignation of Jacqueline Duncan as Councillor and any consequential issues.

The Clerk confirmed that she had acknowledged Cllr Duncan's resignation and informed Harrogate Borough Council accordingly. A Notice of Vacancy has been issued and placed on the notice boards stating that if 10 or more people from the Parish request an Election to take place to fill the vacancy – an election will be held by 17th June, otherwise a new Councillor can be co-opted.

- **19.019 Public Participation** Chairman stated Open to all after each Agenda item for no longer than 3 minutes per person.
- 19.020 Planning Applications the following were considered and discussed: (a) To consider the following Alledged Breach:

It was noted that this sign has now been removed from the roadside.

19.021 Finance

- The Clerk provided a breakdown of payments in and payments out of the bank account since the previous Parish Council meeting.
- The Clerk provided the latest HSBC Bank Statements which showed the figures reconciling with the financial statement provided by Clerk.

19.022 To Discuss appointing an Internal Auditor

Cllr Johnson reported that she had made several enquiries regarding this, including speaking to a recently retired accountant, but without success, and welcomed any further suggestions. Cllr Ann Myatt suggested the possibility of Ian Bales at Ousburn Parish Council.

19.023 To report on progress with Highways

(18.087) No progress to report on the improvement of the road condition following temporary repair measures at the back end of last year. It was thought that this is probably on hold until the new financial year. With regards to HGVs delivering to Oaklands Foods, there is still no sign saying "No Turning Beyond This Point," however it was thought that the problem had somewhat reduced but one remaining issue raised was whether double yellow lines could be installed on the bend at the

end of Church Lane and Main Street – **Cllr Johnson asked the Clerk to check with Highways if this is possible.**

(18.087) Update on progress with Bus Shelter restoration at the junction of the A59 and Church Lane. The Clerk reported that she had been in communication with Cllr Paraskos of NYCC regarding the replacement of the Bus Shelter, who unfortunately had been on sick leave . The Clerk undertook to try and obtain from the Police, details of the insurance company dealing with the accident to enable a claim to be made.

19.025 District Councillors Comments

Cllr Paraskos from NYCC sent his apologies due to recovering from surgery

Cllr Ann Myatt from HBC gave a brief update:

- Apologised for raising the Council Tax which was mainly due to Police Commissioner costs, otherwise there was no significant change for this area.
- Commented on LED lights being introduced by HBC as a cost saving measure. Also a possible change to the Recycling due to a reduction in plastic and the possible segregation of food waste.
- Cllr Myatt and Cllr Johnson had attended a Parish Consultation meeting
 where it was reported that there had been a reduction in the number of
 houses in the Green Hammerton development plan and Inspectors had said
 that some sites of beauty should be removed from the plans. Due to Flaxby
 Developers claiming that due process had not been followed, HBC are now
 making further assessments.

19.026 Defibrillator Update

Parishioner, Trevor Woodward stated that the replacement Defibrillator is still in situ and he continues to check it on a weekly basis.

19.027 Minor Matters
